

Life is Great - by Dr. Bob Carmichael

Time Capsule

A burst appendix smacked me unexpectedly in the hospital, July 23rd for eight days. Besides the IV, morphine, and catheter another 4 days were spent hooked up the a "damn" nasopharygeal tube. With no food, drink or anything except ice chips down my throat to stop constant gagging, my body and mind came to some humbling basics. I wish to share them with you.

1. My past cares, concerns and stresses of life and dentistry are gone and meaningless.

2. I am lucky and a tough son-of-a-gun.

3. I have the best family and friends in the world, their prayers and best wishes worked a miracle.

4. My four physicians were superb and worked together harmoniously.

5. The four shifts of nursing care each day at Sacred Heart were outstanding. They poke, prod, take constant vital signs, force you to exercise, bathe you and wait on you hand and foot, port and portal, every minute of the day and night with smiling personalities that mimic angels of heaven. Something is wrong with our value of professional services here. Why do these R.N.s make half as much the salary dental hygienists make?

6. My four call dentists rushed to my bedside and cared for my patients as if they were their own, and my great dental staff of six held the fort in my absence. 7. LCDS President, Richard Epplett rushed to my bed with all his waiting room magazines so I would not get bored. The members of the LCDS sent a gorgeous wicker fishing creel filled with flowers, chocolate (fish) candy, and 3 wooden fish. (I love to fish.)

8. However, what will be remembered by me forever will be the ever smiling and seemingly omnipresent... the one and only Dr. Glen Purdy, who was at my bedside each of my toughest 3 mornings, with his cheerful encouragement and holding my hand in rough times. He is a combination of Christ, my deceased father, and Santa Claus all rolled into one. Glen Purdy- we are so fortunate to have him little Eugene, Oregon USA. He is one the most remarkable men on the planet.

9. Finally... the fast lane sucks. My life is simplified. My mind is purified. My body has shed its fat. The stresses are gone. No coffee, alcohol or junk food will ever pollute my body and mind again. No dental practice will stress me as it did. Everything now becomes simplified. A very different, wiser, humbled, and grateful Robert A. Carmichael wheel-chaired out of Sacred Heart on July 31, 1990.

Member Spotlight: Dr. Lewis Blue, Retired Dentist and Past LCDS President

Born in Oklahoma, Dr. Lewis Blue moved with his family from to Eugene when he was six years old. He knew he wanted to be in the health field since he was in Junior High. After his brother entered a pre-dental program, he decided he wanted to be a dentist. Dr. Blue attended the University of Oregon School of Dentistry, and while pursuing his profession, he also was very active in student government. He met his wife, Judy, while attending Dental School. He was a senior, and she was in her first year studying to be a dental hygienist. They married after she graduated.

Dr. Lewis Blue started a General Dentistry practice in 1964, which became the Oakway Dental Group when three others joined the practice. While practicing, Dr. Blue enjoyed how grateful people were when he was able to provide the care that they needed.

His wife, Judy, assisted him in his practice as a receptionist and a part-time hygienist while they raised their daughter and son. Judy was also a teacher for Lane Community College's dental hygiene program for over twenty years. Dr. Blue joined LCDS in 1964. Dr. Keith Stenshoel called Dr. Blue and told him he needed to get involved. This friendly spurring led to Dr. Blue becoming an officer for Lane County Dental Society, holding many roles, including president in 1984. He was also active in the Oregon Dental Association, Oregon Academy of General Dentistry, and the Oregon Board of Dentistry. Dr. Blue stresses the importance of representation, "It would be wonderful if more members would get involved at the local and state level. It is disappointing to me that Lane County doesn't have anyone on the Board of Dentistry. Being one of the larger populated areas in the state, Lane needs to be represented on the BOD." Even now, Dr. Blue is assisting with the planning of the LCDS' June 2023 retiree luncheon.

Now Dr. Blue is retired, golfing, and enjoying his four granddaughters. He remembers attending a retirement lecture years ago that helped him get perspective on planning for retirement. This speaker stressed the importance of not thinking that you will spend less money during retirement. "You won't! So, plan accordingly!"

Did you miss November's HPV webinar? Dentists play an important role in early diagnosis



Dentists play a key role in the early diagnosis of oropharyngeal cancers. Not only is it their responsibility to educate their patients of this HPV cancer, but they should

also promote vaccine awareness to help prevent five additional cancers. Here are some important steps for dentists to take:

- 1. Educate themselves on HPV diseases and the vaccine.
- 2. Educate your entire team about the link between HPV infection and oropharyngeal cancer.
- 3. Provide information via displaying office posters and distributing HPV patient brochures.
- 4. Add HPV questions to your office Health History forms.
- 5. Partner with pediatricians and primary care providers as well as ENTs for ease of referrals.
- 6. Recommend HPV Vaccinations.

Dental oral cancer exams rarely include the larynx or pharynx primarily because we can't see it. Medical oncologists recommend, for early oropharyngeal cancer diagnosis, to ask patients these questions while performing the normal oral cancer exam:

- 1. Do you have any white or red patches on your tongue or tonsils that have been there over two weeks?
- 2. Do you have excessive phlegm buildup causing you to constantly clear throat?
- 3. Do you have persistent coughing?
- 4. Have you noticed your voice changing or do you have bouts of hoarseness?

- 5. Do you have a persistent sore throat or a feeling that something is caught in your throat?
- 6. Do you have difficulty swallowing or chewing?
- 7. Do you have difficulty moving your jaw or tongue?
- 8. Do you have numbress of your tongue or any other areas of your mouth?
- 9. Do you have a lump in your neck that may or may not be tender or painful?
- 10. Are your cervical lymph glands sore or tender?
- 11. Do you have unexplained weight loss or persistent bad breath?

It is important to note that a "yes" answer, in and of itself, does not constitute a diagnosis of throat cancer. "Yes" answers to several questions should raise enough concern to recommend a referral.
